- 1. $\underline{\text{Situation}}$. This correspondence transmits a revision to Volume 4 (Marine Corps Victims' Legal Counsel Organization) of the LSAM.
- 2. Mission. To notify all on the distribution list of the revised volume.
- 3. Execution. Volume 4 is revised as follows:
- a. The roles and responsibilities of the Marine Corps Victims' Legal Counsel Organization (VLCO) and its personnel were revised, including the designation of the Chief Victims' Legal Counsel of the Marine Corps as the Officer in Charge of the VLCO and designation of the Deputy Officer in Charge, VLCO, as the Director of the Victims' Legal Counsel Assistance Program.
- b. The eligibility for Victim's Legal Counsel (VLC) services was expanded to include victims of sexual assault, domestic violence, and other crimes under the Uniform Code of Military Justice as permitted by 10 U.S.C. §§ 1044, 1044e, and 1565b, the Manual of the Judge Advocate General (JAGINST 5800.7G (JAGMAN)), and pursuant to guidance published by the Chief Victims' Legal Counsel of the Marine Corps. The scope of VLC services was also expanded to include confidential counseling and assistance in various areas, including the ability to participate in the Catch a Serial Offender (CATCH) program, the availability of and protections offered by military protective orders and civilian restraining orders, and other rights or benefits provided to victims under military, state, and federal law or regulations.

c. Every chapter is updated to be consistent with changes to law and policy.
