- (2) Defense Language Proficiency Test /Oral Proficiency Interview (DLPT/OPI) Score Extension Waiver Request(Example)
- (3) Foreign Language Proficiency Bonus (FLPB) Written Agreement (Example)
- 1. <u>Situation</u>. To provide policy, guidance, and updates to criteria for determining eligibility for the Foreign Language Proficiency Bonus (FLPB) and instructions for FLPB administration in accordance with the references. Fiscal requirements compel the Marine Corps to establish a more flexible incentive payment scheme that recognizes the value of vital foreign language capabilities and total force language skills while allowing for adjustments as the FLPB budget fluctuates. This Order is in accordance with references (a) through (1).
- 2. Cancellation. MCO 7220.52F.
- 3.  $\underline{\text{Mission}}$ . To recruit, retain, develop and enhance foreign language capabilities by providing incentive bonuses to Marines with demonstrated foreign language skills.

#### 4. Execution

- a. Commander's Intent and Concept of Operations
- (1) <u>Commander's Intent</u>. The FLPB is intended to provide bonuses to Marines with demonstrated foreign language skills who meet criteria

established by this Order. Assignments involving foreign language translation and interpretation duties require extraordinary effort to learn, sustain, and improve foreign language skills, which are highly perishable by nature. FLPB is a monetary incentive program designed to reward and retain a cadre of highly qualified personnel motivated to maintain and improve their proficiency in designated foreign languages. As such, FLPB provides an incentive to maintain or increase proficiency in languages of critical importance.

#### (2) Concept of Operations

- (a) Eligibility. In accordance with references (a) and (b), FLPB intends to provide incentive bonuses for Marines who have a validated foreign language capability. Validation is gained via official Department of Defense (DoD) testing mechanisms: Defense Language Proficiency Test (DLPT) or Oral Proficiency Interview (OPI). FLPB is an annual bonus paid in 12 monthly installments, or by lump sum as required. The Secretary of the Navy (SECNAV) delegated authority to the Commandant of the Marine Corps (CMC) to develop policy and procedures for administering the FLPB program and establish/modify FLPB rates within the Marine Corps. Per reference (c), the Senior Language Authority (SLA) under the appointment and executive oversight of the Deputy Commandant for Information (DC I) and in coordination with the Deputy Commandant for Plans, Policies, and Operations (DC PP&O); the Deputy Commandant for Manpower and Reserve Affairs (DC M&RA); and the Commanding General of Training and Education Command (CG TECOM), determines, based on mission analysis, which Military Occupational Specialties (MOSs) and billets require language training and to what level of proficiency. The SLA, DC PP&O and DC M&RA then determine which Marines with the specified MOSs and in particular billets are eligible for FLPB.
- <u>Requirements</u>. Marines with a Primary Military Occupational Specialty (PMOS) in MOS OCC Fields 02XX (Intelligence), 26XX (Signals Intelligence/Ground Electronic Warfare), or 17XX (Information Maneuver) must also possess the 27XX Exception Military Occupational Specialty (EMOS) associated with the language, e.g., 2791 for Russian. Requirements for receipt of a 27XX EMOS can be found in the MOS Manual. Foreign Area Officers (FAO) (MOS 824X), Foreign Area Staff (FAS) Non-Commissioned Officers (MOS 823X), MARSOC Critical Skills Operators (MOS 0372), and Special Operations Officers (MOS 0370) are eligible for FLPB in languages specified in reference (e) or as listed in the annual FLPB MARADMIN.
- 2. Pay by Monitored Command Code (MCC). Marines stationed overseas or assigned to special programs who demonstrate minimum proficiency of Interagency Language Roundtable (ILR) Level 2 in any modality (Reading, Listening, Speaking) are eligible to receive FLPB via MCC for specific, corresponding languages. The list of approved MCCs and languages eligible for pay under this category can be found in the annual FLPB MARADMIN or the FLP SharePoint at https://go.intelink.gov/FLP
- $\underline{3}$ . Payment by Exception. Marines who do not meet MOS or situational eligibility requirements, but are temporarily assigned to duties which actively utilize foreign language capabilites, may submit Exception to Policy (ETP) requests to the FLPB Program Manager for adjudication. Approved requests will be paid retroactively and only for the duration of the assignment. Instructions for submitting an ETP can be found in paragraph 5.g.

- $\underline{4}$ . Lump-Sum Bonus to Formally Certify Self-Assessed Proficiency. In accordance with reference (b), Marines who do not otherwise qualify to receive monthly FLPB may be eligible for an annual lump-sum bonus to formally certify self-professed proficiency. Current guidance and eligibility requirements for payment under this program can be found in the annual FLPB MARADMIN. The Marine Corps reserves the right to cease lump-sum bonuses via MARADMIN amendment or add/remove languages from eligibility contingent on budgetary availability.
- $\underline{5}$ . This Order does not address foreign language pay for civilians. Additional information on civilian foreign language pay may be found in local command orders or in DoD Instruction 1400.25.

### b. Coordinating Instructions

- (1) <u>Testing</u>. In accordance with reference (b), FLPB certification requires qualified Marines to test within the last 12 months and prove their proficiency in a designated foreign language. To meet eligibility requirements for continuous FLPB, qualified Marines shall recertify annually. An exception to the annual recertification requirement is granted to Marines who achieve an ILR level 3 in any modality (Listening, Reading, Speaking); these Marines are authorized to recertify in that modality every two years. Marines shall test using the current version of the DLPT, OPI, or another test designated by the Commandant of the Defense Language Institute-Foreign Language Center (DLIFLC).
- (a) The DLPT tests proficiency in the listening and reading modalities. Per reference (f), only the lower range, upper range, and all range DLPTs qualify Marines for FLPB; very low range DLPT scores do not. During the in-service retest of the language, Marines will be administered the Listening and Reading subtests in the most current version of the DLPT.
- (b) The OPI measures speaking proficiency according to ILR-level descriptions. The speaking proficiency test consists of consists of a 30- to 45-minute dialogue, either in person or over the telephone, between certified instructor(s) and the Marine being tested. DLIFLC reports a speaking score for the OPI. For Marines assigned to United States Special Operations Command and MARSOC, DLIFLC reports a speaking score and a participatory listening score for the OPI.
- (c) If no DLPT exists for a language or dialect, Marines must take the OPI to receive FLPB. In these instances, the score on the OPI will be recorded as both the listening and speaking score and paid accordingly.

## (2) Award Levels

- (a) FLPB will be awarded based on current DLPT and OPI proficiency levels, by modality, in accordance with the FLPB MARADMIN that corresponds with the fiscal year that the test was taken.
- (b) The minimum qualifying FLPB proficiency level on all DLPT/OPI subtests (L/R/S) is ILR level 2, except in the cases of specific MOS requirements, as stated in the FLPB MARADMIN. As an exception, FLPB at ILR level 1 and 1+ may be authorized for Marines in units, individual billets, or special missions requiring that skill level. These circumstances will be

published annually or as needed via separate correspondence by HQMC DC I IID in coordination with DC M&RA, DC PP&O, and CG TECOM.

- (c) Monthly FLPB shall not exceed the limits outlined in ref (a), "Skill incentive pay or proficiency bonus."
- (d) Reference (b) establishes DoD directed FLPB Monthly Payment Calculated by Critical Skill Modality Proficiency. The reference does not allow the Marine Corps to modify payment amounts for ILR levels 2+ and above, however it does allow the Marine Corps to modify payment amounts for ILR level 2 and below, to include no payment. Unless otherwise stated in the corresponding fiscal year FLPB MARADMIN, the FLPB rates are as follows:

- (3) Foreign Language Proficiency Bonus (FLPB) Start/Restart Dates. FLPB starts or continues automatically on the DLPT certification date for active duty and reserve Marines who meet eligibility criteria listed in paragraphs 4.a.(2)(a) and whose DLPT remains current by annual recertification in accordance with this Order's provisions.
- (4) <u>Individual Eligibility Termination</u>. Continued entitlement to FLPB is contingent upon the Marine maintaining qualifications and eligibility. FLPB will automatically terminate if any of the conditions listed below occur:
- (a) Failure to meet annual recertification requirements per this Order. In accordance with references (a) and (b), certification of a Marine's foreign language proficiency will expire one or two years from the first day of the first month after the certification date unless recertified. (For example, if a Marine tests below level 3 proficiency on a modality, on 02 January 2023, their certification for that individual modality will expire 01 February 2024. If that Marine scores a 3, or above, on a modality, the certification will expire 01 February 2025.)
- (b) Failure to achieve or maintain the minimum level of proficiency required by reference (b) and this Order.
- (c) Loss of eligibility due to loss of a qualifying MOS, Permanent Change of Station, or other occasion as required by paragraphs 4.a.(2)(a)1-3 of this Order.

#### 5. Administration and Logistics

a. Installation Personnel Administration Centers (IPAC) and unit S-1 offices cannot report the "start" and "stop" of FLPB on the unit diary; only

HQMC DC M&RA, Manpower Studies and Analysis Branch, is authorized to perform this function. FLPB "start" and "stop" occurs automatically within the Marine Corps Total Force System (MCTFS) for Marines authorized FLPB under paragraphs 4.a.(2)(a)1-3, based upon reporting of a qualifying DLPT/OPI score by HQMC DC M&RA (MPA).

- b. The DLPT or OPI will be administered at approved Marine Corps testing facilities using current testing procedures.
- c. Marines who test at Joint Language Centers must ensure that testing administrators in these facilities register them as Marines in the Defense Language Authorization Reporting System and the Oral Proficiency Authorization and Reporting System. Marines experiencing issues with reporting DLPT/OPI scores should first contact the local testing center that facilitated the test. If issues persist, the Marine should contact their Command Language Program Manager (CLPM) for assistance. In the case of Marines assigned to units that do not have a CLPM, the Marine should contact the Marine Corps Foreign Language Program directly at ForeignLanguageProgram@usmc.mil.

#### d. Defense Language Proficiency Test (DLPT) Retesting

- (1) To ensure test integrity and minimize test exposure, a minimum of 270 days must pass before a retest is authorized, unless approved for a waiver under the provisions listed in paragraph 4.d.(2)(c) of this Order Regardless of waiver status, a Marine may not take more than two iterations of the same test in a 12-month period.
- (2) Marines who achieve level 3+ or higher on the upper range (UR) DLPT within the last 24 months may recertify with a subsequent UR test.
- e. <u>Waivers</u>. HQMC DC I IID is authorized to waive provisions of this Order within the limitations of references (a), (b), and (d). HQMC DC M&RA, Manpower Studies and Analysis, is granted authority to waive retesting provisions of this Order within limitations of references (f) and (g).
- (1) Early Retest Waivers. HQMC DC I IID may waive the minimum time requirement of 270 days between iterations of a DLPT/OPI. Once a waiver is granted, the retesting date becomes the new date for annual recertification purposes and consecutive requests for exception will not be considered. An early retest waiver may be approved for for the following occasions:
- (a) Upon completion of a Significant Language Training Event (SLTE) in that language or dialect. A SLTE consists of a minimum of 150 hours of continuous training or separate training events over time that equal 150 hours.
  - (b) Pending deployment.
  - (c) When entering a service-sponsored school.
- (2) <u>Defense Language Proficiency Test/Oral Proficiency Interview</u>
  (DLPT/OPI) <u>Score Extension Waivers</u>. HQMC DC I IID may waive DLPT/OPI recertification requirements for FLPB eligibility and extend the retest deadline to 90 days after the Marine's return to home station:

- (a) When temporarily assigned to a location with no DLPT testing site within  $50\ \mathrm{miles}$  of their location.
  - (b) When deployed in support of operations.
  - (c) When enrolled in a Service-sponsored school.
- (d) When scores for any language or dialect expire during a SLTE, regardless of which language the SLTE is for.
- (3) Enclosures (1) and (2) contain sample formats for early retest and DLPT/OPI score extension waivers. Additional examples can be found on the Foreign Language Program SharePoint.
- (4) To be eligible for any waiver, Marines must have FLPB-eligible test scores on record and receive FLPB at the time of such request. Waivers will not be considered if submitted after proficiency expiration has expired.
- (5) The Federal-Tax-Withholding-604-Remark in MCTFS qualifies Marines for FLPB automatic extension. HQMC DC I IID coordinates with Defense Finance Accounting Service (DFAS) to ensure proper identification of all deployed Marines who qualify for the automatic waiver. No action is required on the part of individual Marines or units beyond ensuring Combat Tax Exclusion Codes are properly entered into MCTFS.
- (6) Not all deployed Marines rate Federal-Tax-Withholding-604-Remarks in MCTFS. Deployed Marines falling into this category should provide documentation of deployment location, dates, and operation via their Commanding Officer/Officer In Charge using the waiver request provided in enclosure (2).
- (7) All Marines preparing for deployment who are eligible to retest should make every effort to retest before deployment. Commands should consider language retesting in their pre-deployment training plans.
- f. Forward all requests for information or payment through the normal chain of command via standard Naval correspondence via email with PDF attachment to ForeignLanguageProgram@usmc.mil or the following address:

- g. Exceptions to Policy (ETP). To initiate a request to receive FLPB by exception, Marines should provide signed correspondence in accordance with the template found at:  $\frac{\text{https://go.intelink.gov/FLP}}{\text{requests is the first O-5 in the Marine's chain of command or, in the alternative, any personnel with By Direction signature authority.}$
- h. <u>Written Agreement</u>. In accordance with reference (b), a Marine must enter into a written agreement with the Marine Corps in order to qualify for payment of a proficiency bonus. The written agreement shall specify the amount of the proficiency bonus, the period for which the bonus will be paid, and the initial certification or recertification necessary for payment of the proficiency bonus. Individual commands are responsible for facilitating the written agreement and ensuring it is recorded as a Page 11 entry in the

Marine's Service Record Book or Officer Qualification Record using the format in enclosure (3).

- i. Approval. Reviewed and approved per the date of signature. The entitlement provisions of this Order were approved by the Department of Defense Military Pay and Allowance Committee under procedures prescribed by the Secretary of Defense, pursuant to section 1001 of Title 37, U.S.C. and are in accordance with guidelines contained in references (a) and (b).
- j. Records Management. Records created as a result of this Order shall be managed according to National Archives and Records Administration (NARA)—approved dispositions in reference (h), SECNAV M-5210.1, to ensure proper maintenance, use, accessibility, and preservation, regardless of format or medium. Records disposition schedules are located on the Department of the Navy/Assistant for Administration (DON/AA), Directives and Records Management Division (DRMD) portal page at: <a href="https://portal.secnav.navy.mil/orgs/DUSNM/DONAA/DRM/Records-and-Information-Management/Approved%20Record%20Schedules/Forms/AllItems.aspx">https://portal.secnav.navy.mil/orgs/DUSNM/DONAA/DRM/Records-and-Information-Management/Approved%20Record%20Schedules/Forms/AllItems.aspx</a>. Refer to reference (j), MCO 5210.11F, for Marine Corps records management policy and procedures.
- k. Privacy Act. Any misuse or unauthorized disclosure of Personally Identifiable Information (PII) may result in both civil and criminal penalties. The Department of the Navy (DON) recognizes that the privacy of an individual is a personal and fundamental right that shall be respected and protected. The DON's need to collect, use, maintain, or disseminate PII about individuals for purposes of discharging its statutory responsibilities shall be balanced against the individuals' right to be protected against unwarranted invasion of privacy. All collection, use, maintenance, or dissemination of PII shall be in accordance with the Privacy Act of 1974, as amended [reference (k)] and implemented per reference (i).

#### 6. Command and Signal

- a. Command. This Order applies to the Marine Corps Total Force.
- (1) For purposes of the Reserve Component (RC), the acronym "FLPB" refers synonymously to pay and/or bonuses.
- (2) RC members who satisfy eligibility requirements under reference (a) and (b) shall be paid FLPB. The maximum amount of a foreign language proficiency bonus shall be found in reference (a), Skill Incentive Pay or Proficiency Bonus.
